



The more antibiotics we use, the more antibiotic resistance develops. Exposure to antibiotics allows bacteria to adapt, making them resistant to the drugs. Over time, these resistant bacteria survive and multiply, making infections harder to treat.

Individuals, healthcare organizations, & communities can:


- Wear purple
